## **1 APOLOGIES**

1.1 There were no apologies.

## **2 DECLARATION OF INTERESTS**

2.1 No interests were declared in relation to the issues scheduled for discussion.

## **3 MINUTES OF THE PREVIOUS MEETING**

3.1 The draft minutes of the meeting of 2 August 2011 were agreed without amendment. The inclusion of these minutes on the IFRP website was approved.

## **4 MATTERS ARISING/ACTION POINTS**

4.1 The Panel noted that all Action Points scheduled for completion had been achieved. Any other matters arising will be dealt with under substantive agenda items.

## **5 BRIEFING ON PROCUREMENT PROCEDURES**

- 5.1 Ruth Roberts described the various procurement options and the procedures relating to these. The Panel expressed their gratitude for a very clear explanation.

## **6 DISCUSSION RE VISIT BY RT HON GEORGE REID**

- 6.1 The Panel commented that Mr Reid's visit had been extremely useful. Mr Reid had provided a considerable amount of very helpful advice and a valuable insight into the methodology of the Remuneration Board of the National Assembly for Wales. This was discussed by the Panel and in particular, its relevance to the Northern Ireland Assembly. The Panel recorded their appreciation for Mr Reid's very generous assistance and support. The Chair reported that he had written to Mr Reid to express the Panel's thanks to him.

## **7 CONSULTATION EXERCISE**

- 7.1 It was agreed that the consultation exercise planned in relation the Assembly Members' salaries and office holder allowances would be extended to include Members' expenses and pensions. It was further agreed that the consultation exercise should be launched on 15 September 2011 with a closing date of 9 December 2011. The Secretary undertook to amend the consultation documentation for approval by the Panel.

### **9.2 Research Information**

The Panel asked John Power, Head of Research and Information to provide them with the following information:

- Comparison between volume of legislation dealt with by the Scottish Parliament and that dealt with by the NI Assembly since 1999
- Comparison between the numbers of people in the various occupational classifications in Northern Ireland and Great Britain
- Comparison between the salaries of MLAs and those with similar levels of responsibility in the private sector.
- NICS pay scales (Principal Officer (Grade 7) and above) compared to equivalent rates in GB
- NIA pay scales (AG4 and above)
- Comparison of activity rates in NI and GB
- Copy of the "Remit Letters" to SSRB re GB and NI Civil Service Pay Rounds
- Any paper setting out HM Government's thinking re public sector pay
- Recently published papers re pension reform eg Hutton Report
- Information re current pension schemes for elected members in Westminster, Scotland and Wales
- Any publications giving an academic view of the effectiveness of the Assembly as a legislature
- NI version of Chapters 3 and 4 of "Fit for Purpose" – the report of the Remuneration Board of the National Assembly for Wales (March 2011)
