It is right and fair that MLAs not only face cuts to their mileage and office expenses, but it could also be argued that MLAs should not be able to agree pay increases for themselves unless all public sector pay, the minimum wage, pensions and benefits are rising by at least the same percentage as any proposed MLA pay increase.

We also believe that MLAs should not be paid for using their house as a premises while working at home. As regards question seven, few if any people working in other professions get paid for using their house to work from home in, therefore there should be no proposed \pounds 2,000 personal allowance if MLAs use part of their home as an office.
