#### 1 APOLOGIES

1.1 Dr Etta Campbell was unable to attend this meeting.

#### 2 DECLARATION OF INTERESTS

2.1 No interests were declared in relation to the issues scheduled for discussion.

#### 3 MINUTES OF THE PREVIOUS MEETING

3.1 The draft minutes of the meeting of 1 September 2011 were agreed without amendment. The inclusion of these minutes on the IFRP website was approved.

### 4 MATTERS ARISING/ACTION POINTS

#### 4.1 Action Points

The Panel noted that all Action Points had been completed with the exception of three which will be completed before the next formal meeting of IFRP.

#### 4.2 IFRP Register of Interests

The updated Register of Interests was approved and it was agreed that this should be placed on the IFRP website.

#### 4.3 Survey of Assembly Members

Georgie Campbell informed the Panel that the questionnaires were expected from the printers at the beginning of the following week and that they would be issued to Assembly Members as soon as they were received. It was agreed that a reminder should be issued during week commencing 17 October and that this should include a progress report in relation to the work of the Panel.

## 5 REPORTS OF MEETINGS WITH MLAs etc.

The Panel noted the summary of the comments made by MLAs and others with whom they had met as part of the consultation process.

#### **6 FINANCIAL ISSUES**

6.1 The Panel noted that the Secretary had sought legal advice in relation to a possible interim determination in relation to the Office Costs Allowance. They also noted that the Finance Office has written to MLAs to inform them of the Commission's decision that the 2011 RPI uplift and any subsequent uplifts would not be applied because of budget restraints. It was agreed that this subject would be discussed again when the legal advice had been received.

- 6.2 The Panel was informed that Audit Certificates had been received from Parties which fulfil the current OCE requirements. Mr Stewart also informed the Panel that Office Costs Expenses were only paid on receipt of a statement from the Member concerned that the expenses incurred were wholly necessary and used exclusively to support their Assembly responsibilities. Mr Stewart said that there is currently no protocol in place with the NI Local Government Association re councillor and MLA expenses.
- 6.3 The Panel was informed that some training can be paid from OCE but not training which is related to Party political activities. Each claim is judged on its merits.

- 6.4 A discussion took place in relation to constituency office rents. Richard Stewart undertook to provide the Panel with the following information:
  - An analysis of constituency office rents
  - A average rental cost for both urban and rural constituencies which is considered to be reasonable
  - Rental costs for returning Members including any re-evaluation figure
  - Rental costs for new Members

6.5 Mr Stewart undertook to provide the Panel with a breakdown of the cost of stationery provided to each MLA during the last mandate.

6.6 Mr Stewart confirmed that the Resettlement Allowance is paid only to Members who leave at the end of a mandate, however there is provision for a Member who leaves during a mandate for ill health reasons to be paid such an allowance. He reminded the Panel of the SSRB recommendation that a resettlement allowance should be paid only if a Member fails to be re-elected.

- 7.2 A discussion took place in relation to private sector occupations which might be used as comparitors for MLA salaries and it was agreed to await the outcome of the research currently being undertaken by the Assembly's Research Service before pursuing this issue further.
