1 APOLOGIES

1.1 Apologies had been received before the meeting from Dr Campbell.

2 DECLARATION OF INTERESTS

2.1 No interests were declared with the exception of the issue of the decision by the Assembly Commission in relation to constituency office rents (see para 4.4). Mr McQuillan declared that at the time of the Commission's consideration of this issue and prior to his appointment to IFRP on 1 July 2011, he had acted as an ad hoc adviser to the Commission in his capacity as Chair of the Secretariat Audit and Risk Committee.

3 MINUTES OF THE MEETINGS OF 11 FEBRUARY 2014

3.1 These minutes were approved without amendment.

4 INFORMATION REQUESTED BY THE PANEL

4.1 Payments made, and to whom, under contracts for services Panel members noted that some MLAs were purchasing services from individuals on several occasions. They queried whether these people should be treated as employees of the MLA. The Panel also asked whether, where a service had been purchased, the procurement process had been followed. The Head of Finance undertook to investigate this.

4.2 Constituency offices in East Belfast

The Panel noted the information which had been provided.

4.3 Assembly Members who changed their pension contribution rates following the Panel's 2012 Determination

The Panel noted that only five Assembly Members had changed their pension contribution rates.

4.4 Commission's decision of September 2011 re constituency office rents

The Panel noted the legal advice in relation to the Commission's decision.

4.5 Travel and subsistence for non- executive appointees

The Panel noted that as Parliament Buildings was considered by HMRC as their place of work, their travel costs would be paid through payroll and would be subject to tax and NIC.

4.6 Claim forms for expenses

The Panel noted that when Assembly Members are claiming expenses including rent, they are required to sign a declaration to confirm that the payee is not a connected person and that the payment does not represent a donation to a charitable organisation or a payment to a political party.

5.1 Mr McQuillan gave the Secretary some amendments to be made in relation to his entry in the Register of Interests. Mr McCartan undertook to forward his amendments to the Secretary. The Secretary said that she would contact Dr Campbell to ask if she wished to make any amendments to her entry.
