# 1 APOLOGIES

# 5.1 Chairman's letter of 29 April 2014 to the Chair of the Pension Trustees

# 5.2 Next Steps

The Panel agreed that the level of pension contributions could not be finalised until the Actuarial Report is available. It was therefore decided not to issue a Determination re the Assembly Members' Scheme until the Panel has had an opportunity to scrutinise the Actuarial Report.

Kiera McDonald, Legal Adviser, joined the meeting for discussion of the next agenda item.

# 6 DETERMINATION FOR ADDITIONAL YEAR OF THE MANDATE

- 6.1 Section 11(1) of the Assembly Members (Independent Financial Review and Standards) Act (Northern Ireland) 2011 states that the Panel shall make a Determination only once in respect of each Assembly. Section 11(3)(b) allows the Panel to make a further Determination should there be exceptional circumstances. The Panel agreed that the provision in the recently enacted Northern Ireland (Miscellaneous Provisions) Act 2014 which extended the length of the current and future mandates of the Northern Ireland Assembly from four years to five years constituted "exceptional circumstances".
- 6.2 The Panel identified a number of provisions in the current Determination which will cease to apply after 2015 thus making it essential to have a Determination to cover the additional final year of the mandate. The Panel agreed that since a full consultation exercise had taken place prior to the March 2012 Determination, there would be no need for a further consultation on the provisions for the extra year.
- 6.3 The Panel discussed the issues to be addressed in a new Determination with Ms McDonald and the Secretary undertook to follow up the Panel's verbal requests with formal instructions.

## 8.1 Members of the Assembly who are also councillors

In its current Determination the Panel stated that the salary of any member of the Assembly who is also a councillor will be abated by the full amount of the councillor basic allowance with effect from 1 April 2013. The Panel understands that this deduction is currently made by the relevant council. The Panel agreed to write to the Director of Corporate Services asking that, in the case of any councillor elected in the May 2014 council elections who is also an MLA, the full amount of the councillor basic allowance should be deducted from the Member's salary by the Assembly Secretariat and not the council.
